

THE CORPORATION OF THE TOWN OF LINCOLN

BY-LAW NO. 00-95

A BY-LAW TO PROVIDE FOR REDUCED  
OPENING HOURS FOR POLLING PLACES  
AT INSTITUTIONS AND RETIREMENT HOMES

**WHEREAS:**

1. Subsection 45(7) of the Municipal Elections Act, 1996, S. O. 1996, Chapter 32, provides "on voting day, a voting place shall be provided on the premises of the following:
  - a) an institution for the reception, treatment, or vocational training of members or former members of the Canadian Forces.
  - b) an institution in which on nomination day, 20 or more beds are occupied by persons who are disabled, chronically ill, or infirm.
  - b) a retirement home in which on nomination day, 50 or more beds are occupied. "
2. Subsection 46(1) of the said Act provides that on voting day, voting places shall be open for the electors to vote from 10:00 a.m. until 8:00 p.m.
3. Subsection 46(3) of the said Act provides that despite Subsection 46(1), the Council of a local municipality may pass a by-law with respect to a voting place that is only for the use of residents of an institution or retirement home providing for reduced opening hours.
4. The Council of the Town of Lincoln, for the reasons in Report CS00-233 deems it necessary and expedient to provide for reduced opening hours at polling places for institutions and retirement homes.


NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF LINCOLN ENACTS AS FOLLOWS:

1. That the voting place required to be held at Albright Centre, 5032 Mountain Street, Beamsville, Ontario, pursuant to Section 45(7) of the Municipal Elections Act shall be open for the designated electors to vote from 9:00 am until 12:00 noon.
2. That the voting place required to be held at Bethesda, Fly Road Residence, 3531 Fly Road, Vineland, Ontario, pursuant to Section 45(7) of the Municipal Elections Act shall be open for the designated electors to vote from 12:45 pm to until 1:45 pm.
3. That the voting place required to be held at United Mennonite Home for the Aged, 3311 Menno Street, Vineland, Ontario, pursuant to Section 45(7) of the Municipal Elections Act shall be open for the designated electors to vote from 2:30 pm until 5:30 pm.
4. That the voting place required to be held at Lincoln Lodge, 3429 Rittenhouse Road, Vineland, Ontario, pursuant to Section 45(7) of the Municipal Elections Act shall be open for the designated electors to vote from 6:00 pm until 7:00 pm.

BY-LAW read a SECOND time this 2nd day of October, 2000.
