Inventory Acceleration Project

Overview

Since 2018, the Greenbelt Foundation has been working with Municipal Natural Assets Initiative to build partnerships with municipalities across the Greater Golden Horseshoe, helping to make natural solutions to infrastructure and climate change commonplace. Among other initiatives, the Greenbelt Foundation and MNAI have executed a multi-partner project in the Grindstone Creek Watershed with the cities of Hamilton and Burlington to address significant flood risk to life and property. The Foundation and MNAI are currently supporting over 30 municipal governments in developing natural asset inventories—the first step in full-scale natural asset management plans.

Through the Inventory Acceleration Project, MNAI provides participating municipal governments with a customized natural asset inventory and an interactive dashboard with details of their key natural assets including the condition they are in, the risks they face (e.g., development pressures, forest fires), and a roadmap to help local governments decide what next steps they can take to increase or improve their natural asset management approaches. With this new group of local governments, MNAI will have worked with nearly 100 communities to explore the value of the services nature provides them.

More on Natural Asset Inventories


Inventories provide details on the type of natural assets a local government relies upon, their condition, and the risks they face. A natural asset inventory is just the first component of the Assessment phase, which is just the first of three phases of a full natural asset management project. By itself, an inventory will not give a sense of asset value but is an essential first step in the full natural asset management project.
