BY-LAW NO. 2023-01

A BY-LAW TO ESTABLISH AND REGULATE
PAYMENT OF VARIOUS FEES AND CHARGES
WITHIN THE TOWN OF LINCOLN

WHEREAS Section 391 of the Municipal Act, 2001, S.O. 2001, c.25, as amended, provides that despite any Act, a municipality may pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it and for the use of its property, including property under its control;

AND WHEREAS Section 69 (1) of the Planning Act R.S.O. 1990, c. P. 13, as amended, provides that a municipality may establish a tariff of fees for the processing of applications;

AND WHEREAS Section 7 of the Building Code Act, 1992, S.O. 1992, as amended, authorizes a municipal Council to pass by-laws concerning the issuance of permits and related matters requiring the payment of fees on applications for and on the issuance of permits;

AND WHEREAS the Council of the Corporation of the Town of Lincoln deems it expedient to enact a comprehensive by-law establishing and requiring the payment of fees for information, services, activities and use of Town property;

NOW THEREFORE, the Council of the Corporation of the Town of Lincoln enacts as follows:

1. The fees and charges as set out in Schedule A attached hereto and forming part of this By-law are hereby established and adopted by the Council of the Town of Lincoln.
2. This By-law shall be known as the Fees and Charges By-law.
3. The fees and charges as listed in Schedule A to this By-law include Harmonized Sales Tax (HST), where indicated.
4. All fees and charges applicable under this by-law shall be payable in advance of services being rendered, except for:
 - a. Emergency services
 - b. Actions taken by the Town to rectify failures or by-law infractions on the part of a resident, in which case, the fee payable will be in arrears and invoiced after the service or activity is provided
 - c. Instances where the timing and conditions for payment is prescribed in agreements or contracts approved by Council.
5. In the event that any information, service, activity or use of Town property is requested by a person, and a fee or charge for such information, service, activity or use of Town property has not been specifically provided for in Schedule A, a fee or charge shall be calculated by Town staff to appropriately recover town costs and shall be incorporated into this By-law as soon as is practicable.
6. Fees and charges that have been imposed in accordance with this by-law that remain unpaid after the date on which they are due shall have interest applied at the rate of 1.25% per month until paid in full.
7. All fees owing to the Town that are unpaid are considered a debt to the Town and, together with all interest and penalties accrued thereupon, may be collected by the Town by action, or may be collected by the Town on its

behalf, or may be added to the property tax roll and collected in like manner as taxes.

- 8. The Treasurer is authorized to carry out the administration of this By-law, including but not limited to the enforcement thereof, the collection activity, and for initiating such legal action as may be considered appropriate.
- 9. Should any part of this By-law, including any part of a Schedule attached hereto, be determined by a court of competent jurisdiction to be invalid or of no force, it is the stated intention of Council that such invalid part of this By-law shall be severable from this Bylaw and that the remainder of this By-law, including the remainder of each Schedule, as applicable, shall continue to operate and be in force.
- 10. By-laws 2021-95 are hereby repealed.
- 11. This By-law shall come into force and take effect on February 1, 2023.

TIMING OF PAYMENT OF APPLICATION FEES

Fees are subject to change from time to time. the permit fee is payable at the time of the submission of the application. The balance of the fee as a result of the review of the building permit and all other fees are payable prior to the issuance of a building permit.

REFUND OF FEES

In the event of non-commencement of any project after a permit has been issued, the applicant may, provided a written request has been made, be entitled to a refund of permit fees. The refund shall be determined by the Chief Building Official in accordance with the following schedule which sets out the percentage of fees eligible for refund:

If only administrative functions have been performed, 70% of the fee may be refunded.

If administrative functions, zoning functions and grading reviewing functions have been performed, 60% of the fee may be refunded.

If administrative functions, zoning functions, grading review functions and plan examination functions have been performed, 40% of the fee may be refunded.

If the permit has been issued and no inspections have been performed subsequent to the issuance of the permit 30% of the fee may be refunded. Once any inspections have been performed, no refund will be given.

No refund shall be made of an amount less than \$175.00.

Any payments outstanding to the town shall be deducted from the application fee by the Treasurer, prior to the refund being issued.

2. Square metres is the gross floor area of all floors, mezzanines, lofts and habitable areas for each major occupancy classification measured from the outer face of the exterior walls or center line of a fire separation.
3. There are no deductions from the gross floor area for openings such as stairs, shafts, etc.
4. Unfinished basements and crawl spaces are not used in the fee calculation for new construction and additions. Attached garages are not used in the fee calculation for new dwellings.
5. Major occupancy is based on the Ontario Building Code.
6. New construction and additions include plumbing and other regulated building services and components but does not include septic systems.
7. Revisions or amendment to a permit is \$75.00 per hour with a minimum of \$100.00

9. Relocation permit for a building authorizes the moving of the building only. A separate building permit is required for the foundation and any other construction.
10. Fees for additions shall be calculated at the same rate as stated for major occupancy.
11. Where construction has commenced prior to the issuance of a building permit, the prescribed permit fees shall be doubled. Construction is defined as placing of concrete; installation of plumbing or buried piping for building drain, sewer drainage pipe or water distribution pipe.

Application fees are subject to change from time to time. all application fees are payable upon submission, except those for site plan administration fees, subdivision agreement administration fees, pre-servicing agreement administration fees and development agreement administration fees

The draft plan of subdivision application fee is associated with the initial review of the subdivision proposal only and shall not be deemed to be payment towards the administration and overhead, engineering, legal and other costs incurred by the municipality in preparing and administering subdivision agreements. the subdivision agreement, pre-servicing agreement and development agreement administration fees are payable prior to the registration of the agreement.

The site plan administration fees are payable prior to approval of the site plan, when the signed agreement has been submitted by the applicant to the town.

REFUND OF FEES

If an application is withdrawn prior to circulation to commenting agencies, 70% of the fee may be refunded.

If an application is withdrawn after circulation to commenting agencies but prior to public notice being mailed or advertised, 40% of the fee may be refunded.

If an application is withdrawn after notice of the public meeting being mailed or advertised, but prior to the staff report being prepared, 20% of the fee may be refunded.

In addition, any payments outstanding to the town shall be deducted from the application fee by the Treasurer, prior to the refund being issued by the town.

REACTIVATION

Any application which has been withdrawn or has been inactive for a period of one year shall be considered abandoned and a full fee shall be required to activate a new application.
